

GENERAL TERMS & CONDITIONS

1. Bidders will have to dismantle the existing Diesel Generating Set Alongwith AMF Panel and taken out the scrap materials. All labour, tools and equipment required for dismentalling, loading the Diesel Generating Set alongwith AMF Panel from Site with all leads, etc., shall be born by the bidder/buyer.
2. The inspection of goods/ materials put on Auction at 8, Jan Marg, Chandigarh Housing Board, Sector 9-D, Chandigah, will be permitted to the interested bidders after getting the prior appointment from Sh. Arminster Singh Mobile No 9888014323, Sub Divisional Engineer, Sub Division No. III (Elect.), CHB from 0930 Hrs. to 1600 Hrs on any working day.
3. Diesel Generating Set alongwith AMF Panel offered for sale as scrap (which is more than 15 years old) is on 'AS IS WHERE IS BASIS'. It is expressly understood that the bidder has fully satisfied himself regarding the quality, quantity & condition of auctionable material before bidding. It is presumed that the bidder is fully aware of lot put to auction.
4. Any claim/complaint about the quantity, quality, condition, fitness for use, or any inadequacy in the description of the materials /goods etc. will not be entertained after participation in bidding process or issue of Intimation Letter / Sale Acceptance Letter or sale of the lot.
5. Bidders are required to upload the Mandatory Documents as per Annexure I on the GeM portal for bidding. The document to be uploaded should be legible.
6. Earnest Money deposit (EMD) of Rs.90,000/- shall be deposited through NEFT/RTGS (online mode) at following bank account. Bidders shall be allowed to participate in the auction only after deposit of EMD. The bidder must upload the copy of UTR No/ Transaction slip on the GeM portal.

7. Chandigarh Housing Board reserves the right to withdraw e-Auction without assigning any reason at any stage of e-Auction process.
8. The bids are invited for single lot of Disposal of 600 KVA Diesel Generating Set alongwith AMF Panel and no bid would be accepted for any part of the same. The items shall be sold to the bidder who will quote the consolidated highest rates. The bid shall remain valid for a period of 75 days from the e-Auction date.



9. In no case, bid less than the reserve price shall be accepted.
10. The e-Auction of Disposal of 600 KVA Diesel Generating Set alongwith AMF Panel "AS IS WHERE IS BASIS" would be conducted strictly within the scheduled date and time by way of bidding amongst the qualified bidders and the bidder shall improve their offer in multiples of an amount i.e. Rs.5,000/- i.e. "Bid-increase amount".
11. In case of e-Bidding at the last moment, Bidders are requested to make all the necessary arrangements/alternatives such as power supply backup etc. so that they are able to participate in the e-Auction and submit the bid in time i.e. on or before the bid submission end time.
12. The e-Bidder who submits the highest e-Bid on closure of e-Auction process shall be declared as a successful bidder and a communication to that effect will be issued by the Authorized Officer after getting the approval from the competent authority.
13. Once the bid is placed, the highest bidder shall not be permitted to withdraw or surrender his/their bid on any ground, and in case, he does so, the EMD deposited by him / her / them shall stand forfeited in full.
14. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration.
15. The initial deposit of EMD shall will be refunded without interest to the unsuccessful bidders within 7 (Seven) days from the bid end date.
16. The successful bidder shall have to deposit full & final price, adjusting the EMD already paid including all applicable taxes, within 07 days after the acceptance of bid price by the Authorized Officer. The payment shall be made through RTGS/NEFT in CHB Account given above at S, No.6. In case of default in payment by the successful bidder, the amount already deposited by the offer shall be liable to be forfeited and lot/items shall be put to re-auction and the defaulting bidder shall have no claim/right in respect of amount.
17. As per provisions contained under Section 206 (c) of the Income Tax Act, 1961, Income Tax as applicable of the amount will be payable by the successful bidders.
18. All the statutory and non-statutory dues, taxes, rates, assessment charges, fees etc. owing to anybody and Govt. tax/Levy present as well as future shall be borne by the e-Bidder / participant.
19. In the event of any dispute or difference arising out of this bid, the same shall be referred to the sole Arbitrator appointed by the Chairman, Chandigarh Housing Board. The award of the Arbitrator shall be final and binding on the bidders.
20. The successful bidders will have to start and accomplish the work like dismantling & removal of dismantled materials and clear the site properly within stipulated time of 30 days from the date of receipt of full bid money to the satisfaction of the engineer-in-charge. If the bidder does not remove the



- material from the site within prescribed days, EE can confiscate the balance materials lying at site.
21. The Bidder shall be responsible for protecting the property of the Chandigarh Housing Board, Chandigarh, at the time of dismantle of 600 KVA Diesel Generating Set Alongwith AMF Panel. During dismantle of 600 KVA Diesel Generating Set Alongwith AMF Panel of the materials if any damage occurred, will be compensated/ rectified by the successful bidder. The damage will be assessed by Enginner-in- Charge.
 22. The Buyer will have to fulfill the relevant provisions of all safety and security rules of the Seller/Auctioneer and shall have to be governed by the Rules under the Factories Act and any other statutory Act / Law / Rule prevailing from time to time in respect of themselves and their representatives, workmen and equipments. The Bidder(s) shall provide safety equipment and appliances to their workmen at their own cost.
 23. The Buyer shall be fully responsible for the acts of their representatives / workers and shall fully indemnify the Seller/Auctioneer for losses or damages.
